2 Application method

Substrate preparation

The substrate must be firm, clean, dry, free of loose particles and have a pull-off strength of 1.5 N/mm² minimum.

FLOORFINDER PU-S650 FF SATIN can be applied directly over an existing EP or PU underlay / topping, if the underlay / topping is newly laid (within 12 – 24 hrs) otherwise a light grinding is necessary.

Application

Before starting the application, the material temperature must be close to site conditions. The relative humidity should not exceed 85%.

Mix Component A for 2-3 minutes.

Empty contents of Component B (Hardener) into Component A (Base Resin). Mix with a suitable mixer at a speed of 350 rpm to avoid incorporating excessive air into the mix. Mix for 2-3 minutes.

Transfer the mixture into another clean container and mix for 1-2 minute.

To cover vertical surfaces, add 1 to 3 % of FLOORFINDER X955 (thixotropic agent) and mix for 1 minute or until homogeneous.

Spread the mixed product onto the surface with a squeegee and back roll with a short nap roller. The operative should wear spiked shoes to walk on the still wet coating. The formation of puddles should be avoided. For a good finish, we recommend to roll in one direction with a wide short-pile mohair roller.

For cleaning of tools and other contaminations use FLOORFINDER SO-X10 cleaner.

The second coat can be applied within 24 hrs without grinding. If longer, the surface has to be grinded before over-coating.
